RULES OF THE COMPETION 2023-24

BOTH team captains are requested to ensure results within SEVEN days of the match are

1. The Competition will run from September 2023 and end on 30th April 2024

This is a winter competition played on outside courts and the completion of the leagues relies on the willingness of teams to play their matches.

All matches are to be played on LTA approved tennis surfaces and the home team is responsible for all the costs of the match, to include the provision of six new LTA approved tennis balls. Where a home club offers INDOOR courts to opponents that are not free to members , they may ask their opponents to make a contribution towards the cost. The away team shall not be put under any pressure to agree to such a request. Any agreement must be made at least 3 weeks before the match and confirmed in writing or email by the home captain.'

- 2. Each team will consist of FOUR players (two pairs) placed in order of merit, each pair, *who* will each play each other.
- 3. Rubbers to be best of three set as follows: 2 tie-break sets starting at 6-all, + a Championship Tie Break Set to 10 points with a 2 point advantange which is shown on the score card as 1-0 to the winners.

SCORING & REPORTING RESULTS

4. 1 point will be awarded for each RUBBER won.

The Winning team will receive a win bonus of 1 Point. Therefore a win of :

4-0 = 5 Points to the winning team
3-1=4 Points to the winners & 1 point to losers
2-2 (shoot out) 3 points to winners & 2 point to

In event of a draw (2-2) the result will decided by the following criteria:

The percentage of sets won

If equal, the percentage of games won.

If still equal the on the result of the rubber between the FIRST pairs.

This is called THE SHOOT OUT and the winner is recorded on the results page on the website in the box called SHOOT OUT.

At the conclusion of a match – THE WINNING TEAM is responsible for entering the result on the LTA Web Site. THE LOSING TEAM must confirm the result on the LTA Web Site within 7 days of the match being played.BOTH TEAMS MUST retain a completed EXCEL or PDF format RESULT SHEET – in case of a Result query - Which will allow the Captains concerned to send the sheet to the Organaiser.

THEREFORE ALL RESULTS ARE NOW REPORTED ONLINE VIA THE LTA WEBSITE

- 5. SUBMISSION OF MATCH FIXTURE LISTS:
 Each club with teams entered in the competition
 shall present a complete list of their arranged
 match fixtures to the League Organiser at the
 AGM / FIXTURES MEETING, USING THE
 MATCH DATE FIXTURES DOCUMENT. The
 fixtures will be placed online via the competition
 software "League Planner", to which all competing
 clubswill have access. Should any match date have to
 be re-arranged, Match Secretaries or Team Captains
 MUST advise the League Organiser who will make
 the change.
 - **5.1.** Any club wishing to change a previously agreed fixture date should give a clear 14 days notice to their opponents otherwise their opponents are entitled, in the last resort, to claim a walkover if no alternative date can be agreed.
 - 5.2. On the day of a match if the weather is inclement or doubtful the HOME team CAPTAIN should go to the venue, and considering the weather, inspect the condition of the Courts, 60-90 mins before play is due to start. Make immediate contact with opposing Captain, and decide if any play would be possible within 1 hour of the appointed start time. If Play is NOT possible the match can be postponed - and the Captains should try to decide alternative dates if possible, and advise THE ORGANISER as soon as possible.
 - **5.3.**Where the 14 day notice to postpone is given Rule 9 will be acceptable for the rearrangement of the fixture. Except where the postponement occurs in March or April, in which case the home club must offer 2 dates if the original fixture was in March, or ONE date if the original fixture was in April. TO AVOID POTENTIAL DISPUTES ANY NOTICE TO POSTPONE MUST BE IN WRITING OR EMAIL TO THE OPPOSING TEAM AND COPIED TO THE LEAGUE ORGANISER.
- 6. IF two or more teams score an equal number of points , the order of precedence in the group shall be determined by the percentage of sets won to sets played and should the percentage of sets be equal, the percentage of games won to games played shall decide.

- 7 In the event of the match not being completed due to bad weather, dangerous courts, etc, If one complete round has been played that score will stand unless both captains agree to replay the match, in which case the previous result is cancelled' Where a match is abandoned after the first round and the teams agree to not re-arrange. The Results of the first Round should be submitted and will stand as the accepted result.
- 8 Matches can be played evening and/or weekends. It is important that team captains make contact with their opposite numbers in October and advisable that at least two matches are completed before 31st December. It is essential that all-matches- are completed <u>by</u> 30th April.
- 9 Home teams are responsible for arranging matches and should offer THREE possible dates for the fixture within the set period. The Away team should accept one of these. The Home team must provide the balls. Refreshments only by mutual agreement:

10. PROMOTION & RELEGATION

10.1. Championship Groups.

In the Championship groups the bottom TWO clubs will be relegated.

10.2. All other Divisions (Groups)

In all other divisions winners will promoted and runners up will move across to the parallel division (ie 1A to 1B)

The clubs that occupy the bottom position in each division will be relegated and the club that finishes in the second from bottom position will move across to the parallel division (ie 2B to 2A)

Except in the bottom league, where the last clubs will move across to the parallel division..

WALKOVERS

11. The team awarded a walkover will receive 5 points, but the match will scored as 8 sets to 0 (6-0) in all cases. Teams conceding by walkover will also be penalised with a 1 point penalty.

11.1 NEW RULE

Teams who concede 2 WALKOVERSin a season will be disqualified for the season

ELIGILIBITY OF PLAYERS

- 12 Where a club has two or more teams in an age group the following rules apply
- 12.1 A player may play a maximum of 8 games in any one season in each age group.
- 12.2 A player can only play for one team in the same division.
- 12.3 The Qualification to play for a club shall be bona-fide playing membership of that club prior to a match.
- 13 A club which has 2 or more teams in the same Group MUST play the match between its two teams or more before playing any other team in the same group, and in any case not later than Dec 31st
- **14.** Individuals may play for more than ONE club in a season provided
 - * They are playing in a different age group
 Rule Definition
 which means if you e.g play for Over 55 at DL
 Northwood you can Play Over 45 for Northwood
 LTC (who do not have an Over 55 team) but if you
 Play for Townsend 45's you CANNOT play 55's
 for any other team as Townsend has teams in
 BOTH age groups.
- * They are a paid up tennis member of both clubs
 Only players who reach the age of- 45 years or 55 or 65
 years respectively by 30th April 2024 are eligible.
 HONOURARY club members are eligible to play in the
 Competitions provided staisfactory proof of
 Mmebership is provided to the ORGANISER before
 played for his club team

Members of a 55 team may play for a 45 team.

Over 65 Teams – may play one Over 60 Player (as above) but under 65 Registered nominated player.

OVER 70'S TEAMS MAY SELECT ONE FROM 3
